

Suggested wording for your will

Below are some examples of wording for your will. If you show these to your solicitor, it can help in drawing up your will. Please remember that they should be adapted to suit your particular needs.

Specific or pecuniary bequests

'I give to The Cardiff City FC Community Foundation (Registered Charity Number 1128443) the sum of £.....[insert in words and figures or the specific items to be given] for its general charitable purposes [or insert your preferred area of support] and I further direct that the receipt of the Treasurer or other proper officer of the Foundation shall be a full and sufficient discharge to my executors for the said legacy.'

Residuary bequests

'I give to The Cardiff City FC Community Foundation (Registered Charity Number 1128443)..... [enter the word "all" or a % fractional share of] the residue of my estate for its general charitable purposes [or your preferred area of support] and I further direct that the receipt of the Treasurer or other proper officer of the Foundation shall be a full and sufficient discharge to my executors for the said legacy.'

How to amend your will

You can amend your will at any time by adding a codicil.

Below is an example of suggested wording.

Codicils

'I[full name] of[full address] declare this to be a first [or second or third] codicil to my will dated..... [date of will in words]. In addition to any legacies given in my said will I give The Cardiff City FC Community Foundation (Registered Charity Number 1128443) the sum of [or % residue of estate] £.....[insert in words and figures or the specific items to be given] for its general charitable purposes. In all other respects I confirm my said Will and all other Codicils thereto.'

Important information

Please ensure that any gift in your will to us includes our full name 'The Cardiff City FC Community Foundation', and 'Registered Charity Number 1128443, together with the correct registered address: 'Cardiff City FC Foundation, The Pod, Capital Retail Park, Leckwith Road, Cardiff, CF11 8EG'

Charities can sometimes go through mergers or change their names. It is important that the following clause is also included in your Will:
